Dear Mr. Gugino:

Based upon County of El Dorado records, you have not provided the required water sample results for month of **July 2014 (07/01/14 through 07/31/14)**.

As a public water system permitted under California Code of Regulations, Title 22, Chapter 15, Domestic Water Quality and Monitoring you are required to maintain routine sampling of your water. Enclosed is the required procedural failure notification to your water customers that must be given to each consumer via **notice posting to all cabins, email to cabin owners, and NESWA website posting** as per your emergency notification plan.

Please be advised that California Health and Safety Code, Section 116577 allows this Department to bill for water system compliance issues. Failures to sample will lead to penalties being charged at the department hourly rate of \$143.00. The penalty will be waived one time for this Failure to Sample.

### BACTERIOLOGICAL QUALITY PROCEDURAL FAILURE

This notification of the public is being done in compliance with the California Domestic Water Quality and Monitoring Regulations as a means of keeping the public informed.

The **North Echo Summit Water Association** failed to take and report the required routine sample for bacteriological monitoring of its drinking water during the time period of **July 1, 2014 through July 31, 2014** as specified in Section 64423 (a) of the California Domestic Water Quality and Monitoring Regulations. The bacteriological quality of domestic water is routinely determined by testing for coliform bacteria. Coliform bacteria are indicators of potential contamination and may originate from human, animal, or soil sources. If the coliform standards are met, the water served can be considered as being bacteriologically safe. If they are not met, drinking the water may not necessarily result in illness, but that possibility exists. Routine sampling is important to periodically check water quality.
